## 2009 CHICAGO INTERNATIONAL FILM FESTIVAL (Oct 8-22) Industry Accreditation Policy

The industry pass includes the following benefits and will be available for \$150 through October 21st.

- Admission to private industry screenings to be held weekday mornings.
- Admission to regular Festival screenings 10 minutes prior to start time (based on availability). This does not include Gala and Special Presentations.
- Networking opportunities at select nightly events for filmmakers and industry. This does not include the Festival Centerpiece, Opening Night party and Closing Night party)
- Admission to Festival panel discussions
- Listing in Industry Guide
- Copy of Program Book and Schedule

In order to receive industry credentials for the 45<sup>th</sup> Chicago International Film Festival, all film professionals must submit their industry accreditation application form along with all supporting materials. Any requests submitted without supporting materials will be considered incomplete. Completion of application form and submission of supporting materials does not guarantee accreditation. Applicants will be notified about the status of their requests as soon as possible after receipt of all materials.

In addition to returning a completed application form (below), to apply for Festival accreditation, the applicant must provide:

- A written request sent via regular mail, fax (both with letterhead) or email (with signature), or a URL to a company website.
- Companies/organizations must include a comprehensive up-to-date company/organization profile and a list with the names and titles of the representatives who wish to attend the Festival.
- One high resolution (300dpi) photo to be used for Festival badge.
